


# Sustainable Communities Network (SCN) Activity Report

Reporting Period: July 22, 2024 – August 26, 2024

# 1. Digital Platform Centre (DPC) Upgrade

- Date: Ongoing
- Activity: The Digital Platform Centre (DPC) was upgraded to enhance the quality and effectiveness of educational delivery. The upgrade included the addition of various posters depicting computer lessons, a projector, and a slider for educational purposes. The administrative office was reconfigured to accommodate three staff members, featuring new whiteboards for planning and two additional filing cabinets to improve document management.
- **Outcome:** The upgrades have significantly improved the learning environment, making it more conducive for both staff and students. The administrative office is now better equipped to handle the daily operational needs of the organization.



#### 2. Meeting with Orange Sierra Leone

- **Date:** July 24, 2024
